## Campground Rules and Regulations

- Each site is permitted a maximum of six guests; up to three tents **OR** one RV and one tent. Up to two vehicles are permitted at each site overflow parking is available in the parking area just outside campground exit. Please contact a staff member for required overflow parking tags. Any vehicle left overnight without a hang tag is subject to towing at owner's expense.
- Quiet hours are from 9PM-8AM; however, camping courtesy is in effect 24 hours a day no loud music or profanity/abusive language will be tolerated. Golf carts must remain parked during quiet hours.
- Check in at 1PM; check out at 11AM. Reservations are required and provided site hang tag is required to be on display, at your site, at all times.
- Leave your campsite clean clean up after pets and dispose of trash in the dumpster located at the Dump Station. Washing dishes in the restroom is strictly prohibited. Washing of camping units and/or vehicles is prohibited.
- At all times, pets must be on a leash (no longer than six feet in length), and never left unattended. Dispose of pet waste in provided receptacles. Pets are not permitted inside in any LRCP buildings, including campground restroom facility.
- Fires are permitted in fire pits only; do not leave fires unattended, and be sure to extinguish your fires before departure.
- State law prohibits draining of grey water onto the ground. Please use designated dump station to empty all waste water tanks.
- Do not move picnic tables or fire pits from their locations.
- Smoking is prohibited within all LRCP buildings. Please dispose of cigarette butts in the designated receptacles.
- Stays are limited to 14 nights maximum.
- Uneven surfaces, potentially hazardous wildlife, and weather extremes are part of the natural environment. Be prepared and stay aware. Camping is an outdoor experience. You will encounter nature in our park, including insects and changes of weather. We do not refund for early departures.

## Golf Cart Rules:

- Golf carts are required to meet all of the SCDMV requirements for cart usage on public roads, which includes registration, liability insurance, and licensed operators 16 years of age or older.
- Golf carts are permitted on established roadways and parking lots only do not drive on grass areas, trails or sidewalks.

 Operating a golf cart or any motorized vehicle under the influence of drugs and/or alcohol is unacceptable and expressly forbidden. Any persons caught operating a motorized vehicle while impaired may be asked to leave the park immediately at the sole discretion of Park staff.

Anyone found abusing these Rules & Policies will forfeit their ability to operate a golf cart within Lynches River County Park.

Lynches River County Park reserves the right to add or alter these rules and policies at any time due to any unforeseen occurrences in the future.
